Approval of Bills

Approval of the disbursements from July 27, 2016 to August 9, 2016 was motioned by Commissioner Berrelez and seconded by Commissioner Leahy. Roll Call: all aye. Commissioner Schlick inquired about the payment to Paddock Publications, Inc. in the amount of \$1,579. Director Burton advised that was for Wauconda Fest ads in the Daily Herald. Commissioner Kadlec inquired about the payment for brakes for the Ford 550 and mentioned that District may want to contact MB Garage in the future for brake repair and service.

Committee Reports

- A. Recreation Written report submitted. Superintendent Staton reviewed his report with board members.
- B. Finance No report. Director Burton introduced Business Manager Maura Malloy to board members. Business Manager Malloy advised that she had done a few payrolls, the end of year conversion from Sportsman to Active and that the 2015/2016 fiscal year audit is scheduled for September 7th and 8th. She also advised board members that she will be looking into new finance software. Commissioner Kadlec asked that this be put under new "Unfinished Business".
- C. Maintenance Written report submitted. Superintendent Drinkwine was not in attendance. Director Burton reviewed his report with board members. She also informed board members that there is an issue of a sinkhole near the marina launch.

- F. Administration Director Burton reviewed her report with board members. Included with her report were e-mailed comments from triathlon participants commending the Park District on this year's event.

- A. ICMA-RC 457(b) By Board consensus Director Burton was advised to move forward with the recommendation to switch the employee retirement funds from Edward Jones to ICMA-RC. Director Burton included in the board packet a flyer on ICMA-RC, a public sector retirement program that staff recommends for Park District employees to transfer their monies to from Edward Jones. Director Burton informed board members that there is no cost to the Park District for this to happen. All costs are incurred by the employees and they are very minimal.
- B. Community Center Parking Lot Project By Board consensus Director Burton was advised to move forward with this project. Director Burton did provide the revised drawings of the lot with the original location of the handicap area next the dumpster. She also provided a time-line for the project to be completed by the end of October. Commissioner Schlick reminded Director Burton that the Presidential elections are on November 8th and that project needs to be completed before then, in case there are any delays.
