F. Administration – Executive Director Staton reviewed his Administration Report with the Board which highlighted: Comprehensive Plan Update, Memorial Day Parade, Budget and Appropriation Ordinance 2022-02, Wauconda Fest, Art on Main Street, Audit, Liberty Lakes Homeowners Association, and Dock's Parking.

Triathlon Resolution 2022-03 – Executive Director Staton presented the Board with the annual triathlon resolution: A Resolution Providing For the Indemnification of Certain Highway Authorities to Facilitate the Wauconda Triathlons.
