This year's levy increase will remain at 4.999% and due to the increase in the value of property in the District will generate an additional \$100,000 in revenue while decreasing taxes on an EAV of \$100,000 by approximately \$4.
- B.) Staff Appreciation Party Staton and Director Babicz discussed with the Board the possibility of having a staff appreciation party in late February, early March, and the idea of bringing longevity award recipients to Board meetings quarterly to be recognized. It was decided that staff who would receive a longevity would be invited to a recognition ceremony prior to the start of a Board meeting on a quarterly basis.
