Wauconda Park District Board Meeting March 14, 2023 Community Center

Communications

Executive Director Staton shared a pamphlet with the Board he received at the IAPD Legislative Breakfast on March 3, outlining several pieces of legislation the House and Senate were working on this session.

Approval of Disbursements

- C. Park Maintenance Staton reviewed Director Drinkwine's written report with the Board. Highlights of the report included preparations for the maintenance barn siding, metal work preparation for the installation of the new HVAC system, and preparing keys for the Beach Park Marina for pick-up on April 3.
- D. Risk Management/Support Services Manager Ftacek will provide a written report for the next meeting.
- E. Wauconda Fest The next Wauconda Fest meeting will be on April 12 at 6:00 pm. Sponsorship, Buttons, Food Vendor applications, Golf Carts, ATM's and security of the back gates and beer ticket trailer was discussed.
- F. Administration Staton reviewed his written report with the Board. His report covered the topics listed under New Business and WaucondaFest.

New Business

A. LED Lighting for Ballfields at Cook Park – Executive Director Staton presented the Board with an estimate from Shinetoo Lighting for the replacement of the ballfield lights at Cook Park. This improvement is affordable because of the ComEd Rebate program. A motion to approve the replacement of all ballfield lights at Cook Park, including installation and a remote smart control system, for a total of \$19,120 was made by Commissioner Bader and seconded by Commissioner Carr. Roll Call: all aye.

B. Weed Treatment of Shorelines on Bangs Lake – The Village of Wauconda has been looking into a new program for the treatment of invasive weeds in the lake. It has been decided that this program would be put on hold for this year until mapping of the weed types and what degree an application is necessary. Staton will bring the existing program through Clarke Aquatics to the Board for approval at a future meeting.

Executive Director Staton asked her to submit a resignation letter to the Board confirming this. The Board will discuss a replacement plan at the next meeting.

Commissioner Starkey thanked Commissioner Micelli for her tenure on the Board and stated that he appreciated her opinions during discussions of various topics.

Commissioner Starkey also told the Board that he informally met with two lake users. One who had previously been on the Bangs Lake Advisory Committee. During the conversation he stated that the Park District would be interested in assisting with this committee if it was resurrected. Starkey also talked to Staton about this. Staton has mentioned the Park District's interest in participating to Village Administrator Matson and Public Works Director Mann.
